



## **St. Michael St. Clement Family Participation**

Family volunteers are an important component of St. Michael-St. Clement School, and we offer many opportunities to become involved. Our volunteer events provide a wonderful way to get to know other families within our school and build community. Time given to fundraising events also provides money towards our budgetary expenses and helps to keep the cost of tuition within manageable levels.

The St. Michael-St. Clement School Board has established a requirement that beginning in the 2021-22 school year every family must sign a Family Participation Agreement and commit to volunteering at the two major school fundraisers and at least one additional event. In lieu of participating at three events a family may choose to serve as a chairperson for just one event. Any family member over the age of 21 can fulfill the participation requirement. The failure of a family to fulfill the participation obligation will lead to a service fee of up to \$300.00 to be charged to the family and due prior to the release of report cards of the same school year.

Attached is the Family Participation Agreement with a list of the many opportunities to become involved. The agreement should be completed as soon as possible. Please feel free to add the days and times you are available or jobs that you prefer to volunteer for. As events are being planned the chairperson contact information will be published in the school's weekly communications. Please be sure to reach out to the parent volunteer coordinating those events.

St. Michael-St. Clement School takes the protection of our children very seriously; therefore, volunteers who have regular contact with children must complete the VIRTUS Protecting God's Children training program as required by the Archdiocese of Baltimore.
